This certifies that \_\_\_\_\_, here referred to as Mare Owner, has engaged one service to the following stallion, \_\_\_\_\_ standing at **Snow Quarter Horses**, herein referred to as ("Service Provider") subject to the following conditions. The breeding season for this contract will begin February 1 and close July 1, \_\_\_\_\_. A photo static copy of registration papers (both sides) will be provided to the Service Provider prior to service.

A. **Conditions:** A non-refundable booking fee of \$ \_\_\_\_\_ is due at signing and acceptance of this contract. A non-refundable balance of the stud fee in the amount of \$ \_\_\_\_\_ is **payable prior to semen being shipped** (if serviced by Transported Cool Shipped Semen).

a. **Transported Cool Shipped Semen**

- i. Prior to shipment, \_\_\_\_\_ is due for shipments requesting Next Day Delivery within the United States (Canadian shipments to be quoted)
- ii. Prior to shipment, \_\_\_\_\_ is due for shipments requesting same day delivery by Air (Counter to Counter) within the United States (Canadian shipments to be quoted)
- iii. All requests for transported cool shipped semen shall be filled as received, subject to availability of semen, and at the sole discretion of the Service Provider.
- iv. Mare owner/agent must contact the Service Provider by 7 AM Central Time of the day semen is to be shipped. The mare owner should contact the Service Provider the day prior to the mare needing service.

B. **Rebreeds:** Purchaser shall not be entitled to a refund of fees. The Service Provider shall be held harmless of any resulting foal with genetic diseases including HYPP. All rights of return of service to the stallion are subject to the prepayment of costs listed in Item A. There is no color guarantee. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a return of service will be guaranteed the FOLLOWING YEAR ONLY, providing proper notification is given. Thereafter, the mare owner will be subject to an additional \$500 chute fee, plus any increases in stud fees, if applicable. Rhino vaccinations must be administered to the mare within intervals recommended by the drug manufacturer. Failure to do this will void the Live Foal Guarantee.

C. **Live Foal Guarantee:** Live foal means the foal shall stand and nurse. The Mare Owner agrees that the Stallion Owner and/or Service Provider does not make any guarantee as to the quality or conformation of the foal nor that the foal will be free of infirmity, conformation defect, disease or inherited trait. The Mare Owner verifies that such abortion or death did not result from any act or omission of the Service Provider's subsequent to the mares' departure from **Snow Quarter Horses**. Proper notification will be defined as follows:

- a. If the mare is examined to be in foal but becomes barren during gestation and **Snow Quarter Horses** receives a veterinarian certificate of barrenness within seven days of examination.
- b. If the mare produces a dead foal or a live nonviable foal that is unable to stand alone and nurse and subsequently dies, a veterinarian certificate must be provided to **Snow Quarter Horses** within seven days from the date of death.

D. It is further agreed that should the above named stallion die or become unfit for service this contract shall become null and void. In the event, the Mare Owner has paid the Stallion Service fees, the Mare Owner may breed the above named Mare to another stallion at the Service Provider's that is agreed to by both the Mare Owner and Service Provider. If the above named mare dies during the breeding season then the Mare Owner may substitute another mare that is agreed to by both the Mare Owner and Service Provider.

E. **Governing Law:** This contract shall be governed by the laws of the County of Hunt, State of Texas and shall be binding upon the parties hereto and their personal representatives.

F. **Embryo Transfer Donor Mares:** The Mare Owner acknowledges that only one foal per paid stud fee shall be registered.

G. A Breeder's certificate will be issued to the Mare Owner after all expenses (as outlined in Item A.) have been paid in full (including veterinarian services) and upon notification of the birth of the foal.

H. When the above named Mare Owner signs and returns original copy of this contract to the Stallion Owner(s) or Service Provider, together with the booking fee, it shall be the complete and binding contract of both parties, subject to the above terms and conditions.

By signing this contract the Mare Owner/Authorized Agent acknowledges he/she has read the contract in its entirety and agrees to these terms and conditions.
